

Harm reduction vending machines


A pragmatic, non-stigmatizing, low-barrier, 24/7 platform for delivering harm reduction and other needed health items






Our 'Health To Go' vending machines









Our current items:


- Nasal Naloxone (by itself) & Naloxone Kit: nasal naloxone, face shield, one way breather, gloves
- Fentanyl/xylazine test strip kits: fentanyl/xylazine test strips, microscoop, instructions
- Wound care kits: band-aids, antibiotic ointment, gauze pads, gloves, xeroform, information on treating wounds
- **Hygiene kits:** toothbrushes, toothpaste, tissues, socks, chapstick, soap, mouthwash
- Menstrual kits: period pads, tampons, wipes
- Pregnancy tests
- Safer sex kits: condoms (external, internal), dental dams, lube
- Medication disposal bags
- HIV self-tests







Collecting data to establish efficacy → sustainability

Ensuring adequate number of supplies





Accessing the Vending Machine: Workflow




- 1. Create a username
 - Color + Icon (animal, nature) + Birth year
- 2. Option to answer demographics questions
- 3. Once registered, able to access items & view services
 - Limit of 2 items per day per user
- 4. While waiting for item to be dispensed, option to answer 1-2 additional survey questions
- 5. At end of session, 1-2 follow-up questions

"Emergency" Naloxone: two rows of nasal naloxone available immediately, no registration required

Reading vending machine

- High proportion Hispanic/Latino (67%)
- Located inside a YMCA
 - Residential facility
 - Across the street from county courthouses
 - Available to the community for events, day care, gym, pool, and programs
- Available 24/7 however need to buzz in from 11:00pm to 7:00am.
- Stocked by YMCA employee, packaged by local community center


Pennsylvania's first Health to Go free vending machine launched in Reading

Free wellness and personal care items are available to those who need them.



Harrisburg vending machine

- High proportion African-American (52%)
- Located outside UPMC Harrisburg ED entrance in covered courtyard
 - High-pedestrian area
 - Located near homeless encampments
- Available 24/7
- Items packaged and stocked by Penn State team

May - November




How often are the vending machines being used?


Between our two vending machines, we are seeing an average of **52** sessions/day.

NUMBER OF SESSIONS OVER 6 MONTHS


Our Harrisburg vending machine has more traffic compared to the Reading vending machine.



When are the vending machines being used?




Fairly consistent usage on all days of the week



Higher usage during weekdays



How many items are being dispensed? Between our two vending machines, 6,171 items have been dispensed over the past 6 months.




How many harm reduction items are being dispensed? Between our two vending machines, **2,028** harm reduction items have been dispensed over the past 6 months.



Harrisburg vs. Reading: differences in types of items being dispensed

- Harrisburg is dispensing slightly more items than Reading (3,445 vs. 2,726)
- Reading: hygiene kits (1,169; 42%), wound care kits (488; 18%, and menstrual kits (364; 13%) represent a greater proportion of items/kits dispensed
- Harrisburg: while hygiene kits (777; 22%) are the most popular item, more safer sex kits (661; 19%), Narcan (471; 14%) and drug checking strips (271; 8%) are being dispensed compared to Reading


What services are people interested in? Between our two vending machines, **451** individuals have been interested in connecting with **91** services.




How many people are using the machine?

Between our two vending machines, we have a total of **1,422** unique users.


Our Harrisburg vending machine has slightly more users than Reading vending machine.




Sex/Gender




Race/Ethnicity

Ongoing data collection

- Survey questions associated with products/health, for example:
 - "Have you ever used xylazine checking strips?"
 - "I need naloxone (Narcan) because I want to:"
 - "Do you think this vending machine improves your personal health?"
 - "Do you think this vending machine reduces stigma or negative opinions about naloxone (Narcan)?"
- Focus groups with community organizations & vending machine users
- Outreach to service providers listed on vending machine screen

Costs of the vending machine



Estimate of costs for "smart" vending machine

- \$15,000 one-time cost
 - Configuration of machine, training, shipping & installation
- \$2,700/monthly
 - Ongoing maintenance for software support, updates, hardware rental, data connection (including 10GB/month), maintenance
- Supplies: ~\$2,000/monthly based on current demand
 - Items mostly sourced from Amazon, although able to get free items from DOH (HIV self-tests; condoms; wound care) and DDAP/PCCD (nasal naloxone; drug checking strips)
 - Able to impose limits per user (i.e., 1 hygiene kit/user/weekly) to help maintain supply



Lessons Learned

Pre-Implementation

- Key to have strong coalition of diverse community partners to provide input on implementation & design
- Novelty of the vending machine and "smart" technology may create unexpected layers of planning
- May need to balance competing priorities (privacy vs security, low barrier access vs data collection); this will look different for each community and organization

Post-Implementation

- The machine will jam up!
 - → key to have on-the-ground volunteers stocking and monitoring the machine in the early days
- Need for continued outreach to spread the word about the machine



Smart vending machines:

an innovative way to help reach underserved populations, reduce health disparities, and improve community health

PA can become a leader and model for implementation of this low-barrier approach
